

Statement of Responsibility & Hold Harmless

This Statement and Release pertains to horses brought by the undersigned to Cameron Ranch.

Certify that:

- 1) I am the owner, or authorized representative of the owner, of all the horse(s) listed below, and
- 2) The horse(s) listed below will remain in my full care, custody, and control or in the care custody or control of the individual(s) as listed below at all times that the horse(s) are at Cameron Ranch during the event, and
- 3) I understand that horses may be dangerous animals and that participation in the activities of Cameron Ranch involves inherent risk of serious injury, including permanent disability or death. I further understand that such risks include, but are not limited to, the following:
 - a) The propensity of an equine to behave in ways that such risks may result in injury, death, or loss to persons on or around the equine;
 - b) The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or animals;
 - c) Hazards, including, but not limited to surface or subsurface conditions;
 - d) A collision with another equine, another animal, a person, or an object;
 - e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.
- 4) I and those designated below will show good judgment in managing/handling/riding the horse(s) listed in this document and will make every effort to prevent the horse(s) from biting, kicking, or inflicting injury to any person or causing any damage to personal property or the premises of Cameron Ranch during the event, and
- 5) Each horse that I am bringing to Cameron Ranch is in good health and free of diseases and each horse is suitable for participation in the event where there are a large number of horses and people. None of the horses listed have previously exhibited dangerous behavior.

Further, I as the owner, or authorized representative on behalf of the owner, agree to:

- 1) Indemnify and hold harmless Cameron Ranch, Bill Cameron, & NBR and its agents, officers, employees from and against any and all claims (including lawsuits, administrative claims, or other proceedings), losses, costs, damages or expenses including, but not limited to economic loss, direct, indirect, and consequential damages and attorney fees and expenses, resulting or arising from any and all injuries to or death of any person or damage to any property caused by any act, omission, or neglect of myself or my agents, employees, invitees, guests, or any horse listed below which result in my participation in the event, and
- 2) Bring the horse(s) listed on this document to Cameron Ranch and use the stall spaces and other facilities provided by Cameron Ranch, entirely at my own risk, and
- 3) Promptly remove my horse(s) from Cameron Ranch at the discretion and request of the management, and
- 4) Abide by all rules and instructions of Cameron Ranch.

_____ In consideration of my permission to participate in Natural Born Racers™ Events, I expressly agree and contract on behalf of myself, my heirs, executors, administrators, successors and assigns, that Bill Cameron, Natural Born Racers™, and its staff, officers, directors, representatives, agents, arena owners, organizers, sponsors, and co-sanctioned

affiliated entities (hereinafter "NBR"), shall not be liable for any damages arising from personal injuries (including death) sustained by me or damage to property, as a result of my participation in NBR, regardless of whether such injuries result, in whole or in part, from the negligence of NBR.

_____ By the execution of this Agreement, I accept and assume full responsibility for any and all injuries, damages (both economic and non-economic), and losses of any type, which may occur to me, whether foreseen or unforeseen, and I hereby fully and forever release and discharge NBR, its staff, officers, directors, representatives, agents, and affiliated entities, from any and all claims, demands, damages, rights of action, causes of action, or costs, present or future, whether the same be known or unknown, anticipated, or unanticipated, whether under tort or other civil liability, resulting from or arising out of my participation in NBR Events.

_____ I expressly agree to indemnify and hold NBR harmless against any and all claims, demands, damages, rights of action, or causes of action, of any person or entity, that may arise from injuries or damages sustained by me.

_____ I agree to be solely responsible for my safety and well-being. I understand that NBR does not provide supervision, instruction or assistance relative to my participation in NBR Events at all times.

_____ I agree that NBR has the right to call 911 in the event of a serious injury to myself.

_____ I agree that NBR has the right to call a veterinarian and/or animal removal on my behalf in the event of a serious injury to my horse or a horse under my supervision.

_____ I agree to comply with all rules imposed by NBR regarding participation in NBR Events including, but not limited to, those rules as specified in the "NBR Race Rules & Judging" attached hereto, I agree to conduct myself in a controlled and reasonable manner at all times.

_____ I acknowledge that I should wear an equestrian safety helmet when riding in the event. I also understand that under California Law, any rider under the age of 18 years must wear a helmet when riding.

_____ **I HEREBY EXPRESSLY ASSUME ALL RISK OF HARM** to which I, and those minors accompanying me, may be exposed while observing on the premises and/or participating in NBR Events.

_____ **Finally, I agree to the taking of photographs, videotaping and audio recording of me and those minors under my control; and, to the uncompensated use by the NBR Events and Bill Cameron or their assigns.**

_____ I understand that participation in the activities of NBR Events involves inherent risk of serious injury, including permanent disability or death. I further understand that such risks include, but are not limited to, the following:
