  - e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.
- 4) I and those designated below will show good judgment in managing/handling/riding the horse(s) listed in this document and will make every effort to prevent the horse(s) from biting, kicking, or inflicting injury to any person or causing any damage to personal property or the premises of **Shades of Gold Ranch** during the event, and
- 5) Each horse that I am bringing to **Shades of Gold Ranch** is in good health and free of diseases and each horse is suitable for participation in the event where there are a large number of horses and people. Parents must sign if they have children under the age of 18 attending any of our functions. Please initial next to each paragraph that you have read and agreed to its contents and sign your full legal name at the bottom. You understand it is your responsibility to know the club rules!

\_\_\_\_\_ In consideration of my permission to participate in Shades of Gold Ranch Events, I expressly agree and contract on behalf of myself, my heirs, executors, administrators, successors and assigns, that Becky Lowe, Bill Cameron, Shades of Gold Ranch and its staff, officers, directors, representatives, agents, arena owners, organizers, sponsors, and co-sanctioned affiliated entities (hereinafter "SGR") shall not be liable for any damages arising from personal injuries (including death) sustained by me or damage to property, as a result of my participation in SGR, regardless of whether such injuries result, in whole or in part, from the negligence of SGR.

You are responsible for your own horse feed, cleanup, and bedding.

### Ranch Rules:

- Ⓞ Please drive very slowly (5 miles per hour) while on property
- Ⓞ No alcoholic beverages allowed on premises
- Ⓞ No smoking or campfires allowed on premises
- Ⓞ No unattended children
- Ⓞ NO DOGS ALLOWED. We know how much you love your canine companions, but we ask if you please refrain from bringing them. We wish to minimize any risk to people and horses that could be caused by an untimely bark or just the normal doggy scampering. Thank you for your consideration of other riders and their horses.
  
- Ⓞ Please pick up after yourself and your horses.
- Ⓞ Keep all gates closed.
- Ⓞ Horses are not to be tied to rails, stalls, fences, or overnight to trailers.
- Ⓞ EXCA and Shades of Gold Ranch releases must be signed upon arrival onto premises.

# Shades of Gold Ranch

## Stall Reservation Guidelines

Stall Reservation Deadline:

Stall reservation forms must be received by Shades of Gold Ranch as soon as possible. Please Note: there are a limited number of stalls available. Get your requests in ASAP.

Stabling Fees: The stabling fee is stalls \$15 (pipe corral pens).

### Definition of a "night" of stabling:

Each stall may be occupied only for the nights for which a reservation **is made and paid/owed**. **A "night" is defined as a "24-hour period of time."** The 24-hour period will commence upon check in.

Stabling Together: We will try to accommodate requests from owners expressing an interest in stabling together, but we cannot guarantee specific stabling arrangements.

NO Horses in Trailers Over Night or Tied to Trailers: Under no circumstances may a horse be left in a trailer or tied to a trailer overnight.

Arrival & Check in: Horse owners may begin checking in to receive their stall assignments at the ranch from 12:00 - 6 pm on Friday, and 8:00 am each morning thereafter. Please be sure to indicate your arrival time on your Entry Form under Stall Reservation Fee.
